Ridgeway PAC is running a gift card fundraiser and we are hoping that you would contribute.

Do you buy gift cards as employee rewards & incentives, and/or bonuses? Are you considering gift cards in lieu of a Holiday Gala this year? Do you ever give your customers gift cards as a thank you for their patronage at this time of year? Maybe you're considering it? If so, would you consider purchasing your gift cards through Ridgeway PAC?

Help your employee(s) raise money for Ridgeway PAC by buying gift cards for everyday purchases from some of Canada's largest retailers. They are sold at face value, but earn rebates ranging from 4%- 10% of the purchase price of the cards. A list of retailers which offer rebates for this purpose and their rebate percentages are on the order form that accompanies this letter.

Gift cards are such a wonderful product and buying your gift cards through Ridgeway PAC is a win-win situation. At no additional cost (face-value), you get the gift cards you need; and the person that is asking for your help will raise funds for their child, and other children and parents supported by Ridgeway PAC.

The gift cards themselves are issued directly from the retailer and are the same cards you would purchase if you went directly to the stores to buy them. Buying them this way will save you time, energy, and let you help raise funds towards their goal.

Ridgeway PAC is a registered charity with no employee overhead, any funds raised will be used for re-instating programs that were cut from the budget this year, such as author visits, extra-curricular music programs, classroom-libraries and helping those families that need it in various ways. Currently, we are trying to source and fund rain jackets and boots to distribute to the families that need it.
